RE: Richland County, Ohio Pastor Opposition to Federal Government Restroom Mandate

Dear Distinguished Officials,

On May 13th, 2016 the U.S. Department of Education sent correspondence to school districts and universities across the nation informing them that they may be subject to lawsuit and the withdrawal of federal funding in the event their institution does not include gender identity alongside biological sex as protected persons from discrimination in Title IX of the Education Amendments of 1972. (1) After forty-four years this law has been in effect, the federal government now claims that the original framers of the law intended to allow transgendered persons to choose whichever restroom they prefer at any given time. (2)

In light of this development, our firm conviction is that since "there is no authority except from GOD," (3) since governments are instituted among men, deriving their just powers from the consent of the governed, that whenever government becomes destructive of these ends; it is the right of the people to alter it. (4) Furthermore, we believe that religion, morality, and knowledge are essential to good government. (5) and therefore as pastors in Richland County, Ohio, we oppose this illegitimate reapplication of the law inside our education institutions.

THE ISSUE

This federal government guidance does not apply to just bathrooms, but also to locker rooms, showers, dormitory housing, and overnight hotels for field trips.(6) It bears worth mentioning that **no persons are presently being denied access to a restroom** since there is already equal access provided to all on the basis of biological sex.

According to the White House Press Secretary, the guidance letter sent to schools offered 'suggestions' and 'advice' in response to requests from school administrators from across the country. And that schools 'should not view it' as a threat to their federal funding, (7)

On the contrary, we believe this claim is erroneous since the U.S. Justice Department has already filed a lawsuit against the state of North Carolina over its bathroom law passed by the state legislature and ratified by the Governor assigning restroom access based on the gender listed on a person's birth certificate. (8) Consequently, the Justice Department also publicly threatened to take away North Carolina's Title IX federal funding. (9). Since this guidance already has the force of law, this "guidance" therefore has the same effect as the law.

As the following points out, safety and privacy in the restricted areas mentioned above already have a history of being undermined with this radical application of the law. The Bible is very clear: we as a nation would be wise not to move the ancient boundary stones set up by our ancestors (10)......

IN CONCLUSION

The federal government has demonstrated an open hostility to its citizens and more specifically our women and children by forcing its radical form of orthodoxy which undoubtedly will destabilize the school environment from learning. We cannot sacrifice the safety and privacy of women and children on the altar of political correctness. As pastors and spiritual advisors representing over one hundred congregations in Richland County, Ohio, we officially call for civil disobedience to the unlawful restroom mandate issued by the Department of Education dated May 13, 2016.

As Nehemiah 4:14 states, "Do not be afraid of them, remember the LORD, great and awesome, and fight for your brothers, your sons, your daughters, your wives and your homes."
