On January 25, 2019 at approximately 1645 hours, Crew 142, Officer Natalie E. Flory, and Crew 135B, myself, Officer Dustin S. Daugherty, wearing the uniform of the day and driving marked Dayton police cruisers 160156 (Flory) and 680 (Daugherty) were dispatched to 1875 Needmore Road on a person unresponsive call.

The call comments read as follows [RDC453 16:45:13]

BLK SEDAN ON MEDIAN WITH TINTED WINDOWS, CAN SEE MALE SLUMPED OVER IN VEH [RDC513 16:45:26]

Dup: A BLK 4DR CAR IS SITTING PARTIALLY ON THE MEDIAN AND PARTIALLY IN A LANE, LOOKS LIKE IT WAS INVOLVED IN AN ACCIDENT, LIGHTS ARE STILL ON AND NOBODY WAS SEEN IN OR AROUND IT [RDC386 16:48:04]

< B/M BLK LEATHER JACKET BRIGHT RED JEANS GOT OUT OF HIS CAR WALKED ACROSS THE STREET AND WENT BACK TO THE CAR AT GIVEN. >

Upon arrival, Officer Flory and I observed the described vehicle, a black 2007 Buick Lucerne bearing Ohio license plate number G626809 in the eastbound lanes of traffic with its two front wheels up on the median facing northeast. We then observed the described subject, identified as Robert Hand Jr, standing next to the vehicle. I then made contact with Hand and could immediately smell a strong odor of an intoxicating beverage on his breath. I also observed that his eyes were watery and bloodshot. I then asked Hand to explain to me what happened. Hand then stated that his "little girl" had been driving when the brakes went out and they crashed onto the median. I then asked Hand where his "little girl" was and he stated that she left to go to work. I then asked Hand what her name was and he then stated that he was actually the one who was driving.

At this point, I escorted Hand to my cruiser, cruiser 680, where I secured him in the backseat with the MVR running. I then asked Hand if he had ever had his Miranda Rights read to him before and he stated that he had. I then read Hand his Miranda Rights from a Miranda Rights card provided to me by the Montgomery County Prosecutor's office, and after reading him these rights, he agreed to speak to me without a lawyer present. I then advised Hand that I suspected he was under the influence of alcohol and asked him how much he had drank today. He then advised that he had two shots of Jack Daniels. I asked him when he drank these shots and he stated that he started drinking at 1200 hours and had stopped at 1400 hours. I then asked Hand where he was going and he stated that he had been at a funeral and that he was on his way home.

With this information, I asked Hand if he would be willing to take a field sobriety test and he stated that he would. The first test was the horizontal gaze nystagmus test and I requested for Hand to stand facing me with his feet together and hands at his side. Hand then proceeded to turn around with his back towards me. I advised Hand to turn around and again explained how I wanted him to stand and he again turned his back towards me. Once I was finally able to get Hand in the starting position, I began explaining the test to him and then began. During the test, I observed that his eyes were tracking equally but had lack of smooth pursuit. I also observed nystagmus in both eyes at maximum deviation.

The next test was the walk and turn test. During the instruction phase, Hand could not keep his balance and had to be reminded to stay in the starting position. Hand also started the test too soon by beginning to walk while I was still giving him instructions. On the first nine steps, Hand

used his arms for balance on all steps. He also missed heel to toe on step 2. The actual amount of steps he took was 13. He then performed the turn improperly by not taking a series of small steps. On the second nine steps, Hand used his arms for balance the whole time and missed heel to toe on every step. He took a total of 10 steps on this round.

The final test was the one leg stand test. While explaining the test to Hand, he did not remain in the starting position. During the test, he raised his right foot and put it down on his count of 2, 6, 9, and 12. He also had his arms raised so they were parallel with the ground for the entire test.

Once the test was completed, I escorted Hand back to my cruiser where I then read him the ALS form. After reading him this form, I asked Hand if he would be willing to do a breath test and he stated that he would. I then initiated a mutual aid request for the Ohio State Highway Patrol to perform the test, and they agreed to meet me at the Safety Building. I then transported Hand to the Safety Building where I made contact with Trooper Kyle Harris. We then escorted Hand to the BAC room where Trooper Harris performed the breathalyzer test on Hand. Upon completion of the test, Hand's BAC was .149 g/210L.

I then brought Hand back to my cruiser where I issued him a citation for 4511.19Ala OVI as well as failure to control and multiple driving suspensions. I contacted our Records Section who advised that Hand had one previous OVI conviction in October of 2012 through Montgomery County Ohio, reference case number 2012TRC05003.

Due to Hand's cooperativeness throughout my investigation, I decided to summons arrest Hand instead of physically arresting him and then drove him to his mother's house located at 60 E Mumma Avenue. I then ensured that Hand made it into the house safely and cleared the scene.

The vehicle Hand was driving was towed to Sandy's Towing. There is nothing further to report at this time.
