## NARRATIVE INFORMATION

ON 01/07/2019, I, OFFICER CHRISTOPHER METZLER, CREW 146A DRIVING MARKED DAYTON POLICE DEPARTMENT CRUISER 335, ALONG WITH OFFICER MICHAEL FLOYD, CREW 143A, AND WHILE WEARING THE UNIFORM OF THE DAY WERE DISPATCHED TO A CRIMINAL DAMAGING/ AGGRAVATED MENACING COMPLAINT AT 1875 NEEDMORE RD. \*\*

UPON ARRIVAL WE MADE CONTACT WITH THE VICTIM, LATER IDENTIFIED AS MICHAELA CARPENTER. MICHAELA INFORMED US THAT SHE HAD BEEN ATTEMPTING TO COLLECT A STOLEN, PRELOADED DEBIT CARD FROM HER EX-BOYFRIEND, LATER IDENTIFIED AS CHENDO BUFORD (KNOWN AS BJ BY INVOLVED PARTIES) AT THE GIVEN ADDRESS. SHE STATED THAT WHEN SHE ARRIVED, THERE WAS A LARGE GROUP OF INDIVIDUALS WITH CHENDO WHO BECAME AGGRESSIVE TOWARDS HER. SHE CONTINUED BY STATING THAT DURING THE INTERACTION, CHENDO RETRIEVED A BLACK HANDGUN FROM HIS WAIST BAND AND POINTED IT AT HER, STATING "I'LL KILL YOU BITCH".

MICHAELA THEN GOT INTO HER VEHICLE AND BEGAN TO LEAVE. WHILE ATTEMPTING TO DO SO, AN UNKNOWN INDIVIDUAL IN THE GROUP THREW A LARGE ROCK THROUGH HER BACK WINDOW. MICHAELA STATED THAT AT THE TIME, SHE BELIEVED SHE HAD BEEN SHOT AT, SO SHE STOPPED THE VEHICLE AND CALLED THE POLICE. \*\*

WHILE SPEAKING WITH MICHAELA, A MALE BY THE NAME OF KRISTOPHER BURRESS, WALKED BY. MICHAELA POINTED AT HIM AND STATED "THAT'S KRIS, Y'ALL BETTER GET HIM BEFORE I DO, HE'S INVOLVED IN THIS". I CALLED OUT TO KRISTOPHER AND INFORMED HIM THAT WE NEEDED TO SPEAK WITH HIM. KRISTOPHER WAS PLACED IN THE BACK OF CRUISER 335 AND READ HIS MIRANDA RIGHTS. KRISTOPHER STATED THAT HE HAD GOTTEN INTO DAYTON ONLY 30 MINUTES PRIOR TO COMING INTO CONTACT WITH OFFICERS. HE CONTINUED BY STATING THAT THE ONLY THING HE OBSERVED WAS MICHAELA "BEING CRAZY AND TRYING TO HIT PEOPLE WITH HER CAR." HE ALSO STATED THAT BJ HAD BEEN TRYING TO GET AWAY FROM HER ALL DAY. KRISTOPHER WAS RELEASED AFTER I GATHERED HIS CONTACT INFORMATION.

WHILE SPEAKING WITH KRISTOPHER, OFFICER FLOYD COLLECTED A WRITTEN WITNESS STATEMENT FROM MICHAELA WHICH READS AS FOLLOWS.

"BJ KEPT CALLING MY PHONE TRYING TO WORK THINGS OUT AFTER HE STOLE MY CARD SO HE ASK ME TO MEET UP AT THE SPOT TO TALK AFTER I PULL UP WE TALK TO ARUGE AND I JUST TOLD HIM I WANT MY CARD BACK THE HE CALLED AFTER HE WALK AWAY AND TOLD ME TO MEET UP AT THE GAS STATION I WET IN AND WE START ARUGING HE WALK TOWARD ME AND I PULL OUT MY PEPPER SPRAY BECAUSE I WAS TRIED OF HIM TRYING TO FIGHT ME HE THEN GRAB ME AND HIT MY HEAD AGAIN THE DOOR CORE I START CRYIN THEN HE TOLD ME I CAN HAVE MY CARD BACK AND HE SORRY SO THEN HE TOLD ME TO GO BACK TO THE SPOT SO I WENT BACK TO THE SPOT WHERE WE ALWAY MEET THINKIN HE WAS GONE GIVE ME BACK MY CARD HE THEN WALK OUT SIDE WITH GROUP OF PEOPLE AND I JUST ASK FOR MY CARD BACK BJ WALK IN THE THE HOUSE THEN CAME BACK OUT THEN REACH IN HIS PANTS AND PULL OUT A BLACK HAND GUN POINT AT ME AND SAID BITCH I WILL KILL YOU I TOLD HIM THAT MY YOUNG COUSING WAS IN THE CAR HE THEN PASS THE GUN TO HIS BROTHER KRIS KRIS POINT THE GUN AND SAID BITCH ILL REALLY KILL YOU I BACK UP AND THEN A GUN SHOT WENT OFF LOUD NOIS MY COUSIN SAID THEY JUST SHOT OUT THE BACK WINDOW."

GIVEN THE INFORMATION AT HAND, WE WENT TO BJ'S LAST KNOWN ADDRESS AT 5074 NORTHCREST DR IN AN ATTEMPT TO GATHER HIS SIDE OF THE STORY. WE KNOCKED ON THE DOOR AND WERE MET BY BJ'S MOTHER AND TWO ADULT MALES. THEY INFORMED US THAT BJ WAS NOT THERE BECAUSE HE WAS TRYING TO GET AWAY FROM MICHAELA. THEY ALSO STATED THAT MICHAELA HAD BEEN BEHIND THE ADDRESS SINCE 1100 HOURS ATTEMPTING TO CONTACT HIM AND THAT SHE HAD BEEN THROWING FULL CANS OF PEPSI AT PEOPLE LEAVING THE RESIDENCE.

On 1/8/19, I, Detective McReynolds, was assigned this incident for investigation. I made contact with Michaela Carpenter. She stated that she was with her boyfriend "BJ" on 1/6/19. She stated that she does not know his name but has dated him for approximately two months. She stated that during the entire time that he has been abusive toward her and that she is scared of him. She stated that on 1/6/19 he called her and asked her to give him a ride to get some food. She stated that she went and picked him up and went to get food. She stated that during the time of them getting food that they had gotten into an argument. She stated that she when she dropped him back off he ran inside the residence. She stated that she then returned to her residence. She stated that on 1/7/19 she noticed that her pay pal debit card was gone.

She stated that she contacted him and asked him to return her card to her and he stated that he would return her card and asked to meet her at a gas station near Needmore Road. She stated that she could not tell me where the gas station was due to the fact that she is not familiar with the area. She stated that she believes that it was near a Dominos Pizza. I was able to locate a gas station at 5435 N. Dixie Drive near a Dominos Pizza. She stated that once she got to the gas station that he became aggressive and began to argue with her. She stated that it was at this time that she became afraid that he would hurt her so she attempted to take out her mace which she carries with her because she is scared of him. She stated that he then grabbed her in a "bear hug" and would not let her arms go. She stated that he then struck her head on the door of the gas station and then apologized to her. She stated that he asked her to not call the police and that he would give her card back. She stated that he then said he would meet her at "their spot" behind the address on Northcrest Drive at 1875 Needmore Drive and give her the card back. \* \*

She stated that she then went to the location and met him. She stated that he was with several people and he became increasing upset and agitated. She stated that "BJ", later identified by his mother as Chendo Burford JR., then produced a hand gun out of his waist and pointed the gun at her and stated "I'm gonna kill you". She stated that she was very afraid and told him that her cousin was with her. She stated that Chendo handed the gun to a relative, who is a blood brother to Chendo, and the relative stated that he was going to kill her. She stated that she then attempted to leave in her vehicle and she heard a gun shot. She believed that someone had shot out the back window of her vehicle but later found a rock in her back seat. She stated that she recognized that someone had shot a gun but that the rock had broken the window of her vehicle.

She stated that she did want to press charges and stated that she did not think that Chendo had the right to point the gun at her and threaten to kill her. She stated that the cards taken were not used and that she has not had contact with him since the incident. She stated that she is worried that he will come to her residence and that she is scared of him. She stated that the card has been deactivated and that they could not be used. \*\*

I contacted Detectives from the Violent Crime Unit and asked that if they received the witness statement from the incident to notify me and I would place the statement into the case file.

On 1/9/19 I presented this case to the prosecutor's office for charges on the theft of credit card and the charges were refused. I later made contact with Michaela Carpenter who stated that she was glad charges were refused

because she did not want to prosecute for the theft of the card. I told her per our conversation before that she stated that she wanted to follow through on charges for the aggravated menacing and criminal damaging. I then ordered her into the prosecutor's office on 1/14/19 at 0830 hours. I discussed with her speaking to prosecutor about getting a protection order while there.

I later received the written statement and placed the statement into the case file. This case will be closed with a referral. \*\*\*\*\*\*\*\*\*\* End of Report \*\*\*\*\*\*\*\*\*
