ON APRIL 22, 2022, I, OFFICER CALEB LAWSON, CREW 132, WEARING THE UNIFORM OF THE DAY, DRIVING MARKED POLICE CRUISER 339, WAS DISPATCHED TO 1875 NEEDMORE ROAD, PURE OHIO WELLNESS, AT 1458 HOURS ON A THEFT COMPLAINT.

I CONTACTED SECURITY MANAGER, TYLER STONE, WHO STATED THAT ON APRIL 20, 2022 AT APPROXIMATELY 1250 HOURS, PURE OHIO WELLNESS EMPLOYEE, GARY STEVENS, STOLE TWO .5 OUNCE CONTAINERS OF FLOWER MEDICAL MARIJUANA AND THREE CONTAINERS OF EDIBLE MEDICAL MARIJUANA. STONE STATED THAT THE TOTAL FINANCIAL LOSS WAS \$300.

STONE ADVISED THAT HE AND OTHER PURE OHIO WELLNESS EMPLOYEES OBSERVED THAT SOME OF THEIR PRODUCT WAS MISSING FROM THE STORE AND UPON REVIEWING THEIR SECURITY CAMERA FOOTAGE, THEY WERE ABLE TO FIND THAT STEVENS WAS STEALING THEIR PRODUCTS AT THE END OF HIS SCHEDULED WORK SHIFT.

STONE DESCRIBED STEVENS TO BE A BLACK MALE, BETWEEN 20-25 YEARS OLD, AND WAS LAST SEEN WEARING A BLACK PURE OHIO HOODIE, BLACK SWEATPANTS, BLACK SHOES, AND TO HAVE SHORT BLACK PIGTAILS. STONE STATED THAT STEVENS HAS BEEN TERMINATED SINCE THIS INCIDENT. STONE DID NOT HAVE ANY OF STEVENS PERSONAL IDENTIFICATION INFORMATION AT THE TIME THIS INCIDENT WAS REPORTED.

I SPOKE WITH MULTIPLE PEOPLE FROM PURE WELLNESS. I WAS ABLE TO GET THE SUSPECTS FULL NAME, I OBTAINED HIS NUMBER FROM A TRAFFIC CITATION. I CALLED GARY ON 4-27-22. I ADVISED HIM WHO I WAS. I TOLD HIM HE WAS SEEN ON VIDEO TAKING THE PRODUCT. GARY SAID HE ACTUALLY RETURNED THE PRODUCT PLUS TURNED IN HIS WORK ITEMS. I SPOKE WITH CHRIS AND TYLER FROM PURE WELLNESS. TYLER ADVISED THAT THE PRODUCT WAS RETURNED. HOWEVER, GARY "BROKE" THE SEAL ON THE PRODUCTS CONTAINER. TYLER STATED THAT SINCE GARY HAD DONE THIS THE PRODUCT COULD NO LONGER BE SOLD. I ASKED IF GARY WAS TO PAY THEM FOR THE PRODUCT WOULD THAT BE SATISFACTORY. TYLER SAID HE WOULD NEED TO ASK TRACY. I TOLD THEM TO CALL ME BACK AND LET ME KNOW.
