On February 18th, 2024, at around 0606 hours, Crew 113A, Officer Rhio Kano and myself, Officer Ja'Rome Miller, riding as Crew 116A as a one-person unit, driving marked city of Dayton cruiser 200445, while in the uniform of the day self-dispatched to a Assault complaint at 333 Wayne Avenue.

The call comments explained caller Laura Williams was assaulted by her Ex-boyfriend Eric Lumpkin at the intersection of Wayne/Fifth Street before Lumpkin took off on foot in an unknown direction.

Upon arrival at 333 Wayne Avenue (Columbia Care), Williams was standing up against a wall near the east parking lot of the building alone. Officer Kano and I briefly spoke with Williams before Medics arrived and transported her to Kettering Health of Dayton (Grandview) for a suspected ruptured lunge. * * *

At Grandview, I spoke with Williams, who explained that she and Lumpkin's night began at around 0030 hours to celebrate Williams's birthday. Williams said the couple met up at 329 E Fifth Street (Lily's) to celebrate with drinks and food, and while there the two shared several drinks together

before leaving. Williams said that after leaving the bar, Lumpkin started to get upset with her due to an unknown reason, which caused the two to argue. Williams said the two ended up at an unknown address near the intersection of E Sixth St and Jackson St, where Williams stated to be a friend of Lumpkin's address.

Williams said while at the address, Lumpkin got even more agitated and started yelling at Williams before being told to leave by his friends. Williams said at that time, she no longer felt comfortable, so she intended to leave to catch the nearest bus home. However, Williams stated Lumpkin began cashing her several blocks around the Organ district until he finally caught up to her at the 333 Wayne Ave address, Where he was stated to have thrown Williams up against a wall and punched her once in the face with a closed fist. Williams appeared to have had a swollen top lip, with fresh blood covering the rim of her mouth, as a result of said assault.

Williams stated both Lumpkin and her never lived together nor shared any kids. Williams initially hesitated to file charges against Lumpkin, although, after time to consider, she stated she would. I Gave Williams a report number, and I completed a broadcast for Lumpkin Arrest on sheet 49/Call 10. I have nothing further to report at this time
