On 05-04-2020 at 1451 hours, I, Officer Nicholas White (Crew 824C Cruiser 634), was dispatched to 333 Wayne Av, Strawberry Fields Dayton, on a theft complaint.

On 05-04-2020 at 1451 hours, I, Officer Nicholas White (Crew 824C Cruiser 634), was dispatched to 333 Wayne Av, Strawberry Fields Dayton, on a theft complaint. Call comments stated, "MEDICAL MARIJUANA STOLEN BY A SECURITY OFFICER NAMED NICK ANTONIDES. THIS OCCURED LAST THURSDAY. SUSP NOT O/S, UNK WHEN HE WILL BE BACK. NEGATIVE TO COVID 19 QUESTIONS."

Upon arrival, I made contact with Angela Hamilton and John Black. Hamilton is the General Manager for Strawberry Fields Dayton and Black is a security manager for Columbia Care that oversees Strawberry Fields' security.

Hamilton stated an employee, later identified as Nicholas Antonides, took 5.66 grams of prescribed marijuana out of the storage area on 04-30-2020 around 1844 hours. The raw marijuana was called "O'Ryan" and was valued at around \$80. Hamilton stated the incident is on camera. Hamilton stated you can see Antonides near the area where "mislabeled" items are put together. Hamilton stated that product is not to be sold until fixed. Hamilton stated on the surveillance video at 1844 hours on 04-30-2020, she observed

Antonides pull his sleeve over his hand and place it near the area where the mislabeled marijuana was. Hamilton stated she could not see him take the product but noticed it was missing on 05-01-2020 in the morning. Hamilton stated five other employees were in the dispensary when the theft occurred and she would be able to provide the names at a later time. Hamilton stated she confirmed that the marijuana was not sold or misplaced before calling police and that was why she did not call until 05-04-2020.

Hamilton advised me that The State of Ohio Board of Pharmacy would be instigating the incident as well. Hamilton gave me Detective Haun's phone number who would be conducting the investigation. I spoke with Detective Haun over the phone who requested the assigned detective reach out to him. Haun stated he would do his own separate investigation and present it to Grand Jury pending the investigation. Hamilton stated Antonides was not aware of the allegation.
