Antonides pull his sleeve over his hand and place it near the area where the mislabeled marijuana was. Hamilton stated she could not see him take the product but noticed it was missing on 05-01-2020 in the morning. Hamilton stated five other employees were in the dispensary when the theft occurred and she would be able to provide the names at a later time. Hamilton stated she confirmed that the marijuana was not sold or misplaced before calling police and that was why she did not call until 05-04-2020. ***

Hamilton advised me that The State of Ohio Board of Pharmacy would be instigating the incident as well. Hamilton gave me Detective Haun's phone number who would be conducting the investigation. I spoke with Detective Haun over the phone who requested the assigned detective reach out to him. Haun stated he would do his own separate investigation and present it to Grand Jury pending the investigation. Hamilton stated Antonides was not aware of the allegation.
