ONCE ON THE TELEPHONE WITH THE CALLER IN JAMIE FARMER, HE STATED WHILE HE WAS WAITING IN LINE AT STRAWBERRY FIELDS AN UNKNOWN FEMALE STOLE \$200. JAMIE STATED THAT HE WAS NEXT IN LINE TO ENTER THE BUILDING SO WHILE HE WAS WAITING HE HAD A SEAT. JAMIE STATED THE \$200 THAT WAS IN TWENTY DOLLAR BILLS FELL OUT OF HIS FRONT POCKET WHILE HE WAS SITTING DOWN. ONLY A COUPLE MINUTES WENT BY AND HE WAS ALLOWED TO ENTER THE BUILDING, AS SOON AS HE GOT INSIDE HE REALIZED HIS MONEY WAS NO LONGER IN HIS POCKET. UPON ARRIVAL I SAW THAT 1875 NEEDMORE ROAD IS PURE OHIO WELLNESS WHICH IS A MEDICAL MARIJUANA DISPENSARY, I WAS GREETED BY AN ARMED SECURITY GUARD. HE STATED ONE OF THE WORKERS INSIDE, HAD THEIR VEHICLE BROKEN INTO. THIS GUARD ALLOWED ME TO GAIN ACCESS TO THE SECURE BUILDING. I WAS ASKED TO SIGN IN AND WEAR A BADGE UPON MY ARRIVAL. I WAS DIRECTED TO THE SECURITY ROOM WHERE I MET WITH VICTIM MEGAN HAVER. MEGAN STATED HER VEHICLE WAS UNLOCKED IN THE PARKING LOT OF THE BUSINESS. MEGAN STATED AT 1316 HOURS, AN UNKNOWN SUSPECT OPENED HER CAR DOOR AND TOOK HER WALLET OUT OF HER CAR.

I WATCHED THE VIDEO FOOTAGE FROM PURE OHIO WELLNESS. IT SHOWED A BLACK MALE IN A DARK COLORED JACKET WITH FUR ON IT AND JEANS, WALK UP TO MEGANS RED KIA BEARING OHIO REGISTRATION HHF3977 WHICH WAS PARKED ON THE WEST SIDE OF THE BUILDING, CLOSE TO NORTHCREST APARTMENT COMPLEX. THE VIDEO SHOWS THE SUSPECT WALK FROM NORTHCREST APARTMENT COMPLEX AREA AND ENTER THE OPEN AND UNSECURED PARKING LOT OFFURE OHIO WELLNESS. THE VIDEO SHOWS THE SUSPECT OPEN AND ENTER THE UNLOCKED DRIVERS SIDE FRONT DOOR AND REACH IN THE VEHICLE. THE VIDEO SHOWS THE SUSPECT CLOSE THE DRIVERS DOOR AND WALK SOUTH ACROSS NEEDMORE ROAD. THE SUSPECT GETS HALFWAY ACROSS NEEDMORE ROAD AND RUNS BACK TO THE CAR AND GETS INSIDE THE SAME DOOR ONE MORE TIME. THE SUSPECT WAS LAST SEEN WALKING EAST ON NEEDMORE ROAD.

PURE OHIO WELLNESS WAS UNABLE TO SAVE THIS VIDEO TO A FLASH DRIVE OR CD. PURE OHIO WELLNESS WAS ONLY ABLE TO EMAIL A COPY OF THE VIDEO. DUE TO THE SIZE OF THE VIDEO, THE VIDEO COULD ONLY BE SENT TO A GOOGLE DRIVE ACCOUNT. THE WORKER SENT THE VIDEO TO MY GOOGLE DRIVE ACCOUNT AND I WAS UNABLE TO VIEW THE VIDEO. I FORWARDED THE EMAIL TO MY WORK EMAIL AND WAS UNABLE TO OPEN IT FROM ANY COMPUTER PROGRAM.

MEGAN HAVER'S WALLET WAS TEAL IN COLOR AND WAS 31 GIFTS BRAND. IT CONTAINED HER DRIVERS LICENSE, HER PASSPORT, AND HER SOCIAL SECURITY CARD. THE WALLET ALSO CONTAINED A BLUE CREDIT 1 CREDIT CARD, A GREEN WRIGHT PATT CREDIT UNION DEBIT CARD, AND AN ORANGE PNC BANK DEBIT CARD. \*\*

MEGAN HAS SINCE CANCELLED ALL OF THE DEBIT CARDS AND CREDIT CARD. MEGAN IS ATTEMPTING TO START THE PROCESS TO GET NEW FORMS OF IDENTIFICATION. MEGAN AND HER BUSINESS PURE OHIO WELLNESS WAS PROVIDED WITH THE REPORT NUMBER. MEGAN WAS ADVISED TO CALL IF SHE NOTICES ANY DAMAGES TO HER CAR OR ANY FURTHER INFORMATION FOR THE REPORT. AT THIS TIME THERE ARE NO DAMAGES TO MEGAN'S CAR.

We arrived on scene and were let into the building by security guard, Jacob Sanders. Mr. Sanders showed us a video of the suspect shoplifting marijuana. The business, PureOhio Marijuana Dispensary had numerous surveillance cameras mounted inside the store, including one over the counter. Mr. Sanders played a video from 04-22-2020 at 1607 hours, which showed the suspect, later identified as Ajaib Pureval, steal a small container of marijuana. The video shows Mr. Pureval talking with employees behind the counter and placing some marijuana behind the monitor at the front desk, so it was out of view of the employees. He then purchased a small amount of marijuana and before leaving the counter, grabbed and placed the marijuana he had hidden behind the monitor into his pocket. He then began to leave the dispensary, and Mr. Sanders saw him leaving the building with the stolen marijuana partially visible from his pocket . At no point did the suspect try to pay for the marijuana he concealed in his pocket. He was then stopped by another security guard named Jeremy Snyder along with Mr. Sanders. Mr. Snyder recovered the shoplifted property after confronting the suspect. Mr. Sanders said the marijuana stolen was 8.49 grams and valued at \$48-\$58.

We then talked to the manager of the dispensary, Scott Spinale. Mr. Spinale wanted documentation of the incident so he could report it to the Ohio State Pharmaceutical Board so they could possible revoke the suspect's medical marijuana license. I then gave Mr. Spinale the report number for the incident and ordered him into the Prosecutors office on 04-30-2020 at 0830 hours. Mr. Sanders was unable to burn the video of the incident to a disk but could transfer it to a thumb-drive if needed. Cleared with nothing further to report.

A call was received regarding the dumpster being entered at The Forest(1651 Tiffin Ave.). Morena Bruhn advised the dumpster was entered the night prior and trash was scattered about the enclosed dumpster containment area. Morena said there was nothing of value in the dumpster at the time it was gone through. In reviewing the video, at approximately 11:10 pm, on 4/28/2022 a dark colored sedan arrives in the parking lot of K&K interiors(west of The Forest), and (3) subjects approach the dumpster, as the vehicle departs the area and travel's south on Tiffin Ave. onto the Rt. 6 bridge. The subjects enter the enclosed dumpster area and some how open the dumpster and start going through it. The subject's are observed using flash lights. A short time later, the subjects walk back to K&K parking lot and the vehicle picks them up. They leave the parking lot and travel north on Tiffin Ave. into the city. The identities of the subjects are obscured. Two of them appear to be thin males and one is a shorter female. I checked the dumpster and did not locate anything of evidentiary value and the dumpster was not damaged.

In the video, a SPD cruiser is observed going through The Forest's parking lot 10 minutes later after the subjects left. Morena advised the subject's appeared to be the same ones as before.
