Narrative Report

On 02/03/2022 at 1417 hrs. the Shelby Police department received a complaint from the downstairs resident at 91 Broadway St that Alexander Tittle had fired a rifle into air after an argument over a snowblower. Upon receiving the complaint the Ohio State Highway Patrol and the Richland County Sheriff's Office were requested for assistance. After the incident occurred it was believed Tittle retreated back into the upstairs apartment that was also currently occupied by his wife. Officers surrounded the residence and the Chief of Police was able to make contact with Tittle via the phone. Tittle denied firing a rifle and claimed he was alone inside the apartment. Tittle agreed to comout and turn himself over to law enforcement. Tittle was taken into custody without incident by Detective Turner.

After receiving the complaint that Tittle's wife was inside the apartment when this incident occurred and he was now claiming she wasn't there officers became concerned that she may have been harmed or in harms way. Tittle has a history of arrests from his department for violent offenses. Officers made entry into the apartment to check the welfare of Tittle's wife, Alexis Heather Bellomy-Tittle. She was subsequently located inside the residence and found to be unharmed. While clearing the residence for officer safety officers observed numerous suspected marijuana plants in plain view. Officers also learned that there was a rifle inside the residence and they observed a spent rifle round inside the bedroom.

Alexis Heather Bellomy-Tittle was found to have an active arrest warrant from the Richland County Sheriff's Office for Failure to Appear on a traffic offense of Driving Under Suspension. The warrant was confirmed and she was secured under arrest without incident. Both Alexander Tittle and his wife were transported to the police department while Ofc. Noten stayed at the apartment and secured it for evidence while a search warrant could be prepared.

A search warrant was reviewed by the City of Shelby Law Director and then presented to the Honorable Judge Sheree Studer in reference to Discharging Firearm Offenses, Inducing Panic, Cultivation of Marijuana and Drug Paraphernalia. The search warrant was signed by Judge Studer and upon executing it 13 items of evidence were collected and seized. These items included a rifle matching the description from the witness, a spent rifle cartridge matching the caliber of the rifle, 10 marijuana plants, lighting used for growing marijuana and numerous items of Drug Paraphernalia associated to abusing marijuana and Rx medication. Alexander Tittle was charged with the following offenses in Shelby Municipal Court: Aggravated Menacing (M-1), Pointing and Discharging Firearms and other Weapons (M-4), Falsification (M-1), Obstructing Official Business (M-2), Cultivation of Marijuana (M-4) and Use or Possession of Paraphernalia (M-4). He was given a total cash bond of \$1,575 and incarcerated in jail. Tittle is scheduled to appear in court on 02/07/2022 at 0900 hrs.

02/03/22, 1413 Hrs. Sgt. Baker and I were detailed to 91 Broadway in reference to a call of a man with a gun. Caller advised dispatch that an Alex Tittle was in the upstairs apartment with Heather Bellamy, and that he had discharged a rifle. The caller advised that he was in the basement, and that Alex and Bellamy were upstairs. Sgt. Baker and I arrived in front of the residence and blocked traffic flow with our cruisers. Sgt. Baker held the front of the residence, while I held the rear of the residence on the south east side of 89 Broadway. I noticed stairs leading to the upstairs apartment of 91 Broadway. I was familiar with this residence, and recalled that there was only one way in, and one way out, which was the stairs at the rear leading to and from the apartment. Officer Turner, and Trooper Stephen Gillum from the Mansfield Post arrived near my location. All three of us had eyes on the rear of the apartment. Information was being relayed from dispatch from the complainant that two people were in the upstairs apartment, Tittle and his girlfriend Heather Bellomy.

Chief Combs advised that he had made contact with Tittle, and that he was exiting the house and provided a description of his clothing. Chief Combs also advised that Tittle advised that he was unarmed. I moved closer around the back of 89 Broadway to make contact with Tittle as he exited the apartment. Tittle exited the apartment with his hands raised in the air. The only thing visible in his hands was a cell phone. I began giving Tittle commands to keep his hands in the air, and to turn away from us and look towards the garage. I then advised him to place his cell phone in his back pocket which he complied, and then to put his hands back in the air and then on top of his head. I covered the officers with my riffle on Tittle as he was taken into custody by Officer Turner.

After Tittle was taken into custody, my concern was for the welfare of the female that was also in the upstairs apartment. Tittle began saying that this was over a hammer, and that he said I had a gun. Stated he used the hammer to break a lock on the garage, and that he also smashed the railing with the hammer. He also stated "I'm sure people got my point". Due to the exigent circumstances I was concerned for the well being of the female that reported being inside the apartment. Myself and Trooper Gillum began walking up the stairs to make entry inside the apartment. Tittle began asking why we were going in there. I advised him that we needed to check the residence, to make sure everyone was safe.

I entered the residence and while doing so shouted "POLICE" a couple times and asked if anyone was in there. Female responded "yes, yes", and came out of a back room with her hands in the air. I advised her to keep her hands on top of her head. I advised her that I wa making sure she was safe. I advised Trooper Gillum to detail the female with I completed a primary search of the residence for anyone else. During that search a door to a room was partially open with lights on, and I could see what appeared to be marijuana plants. I opened the door to clear the room and determined that there was a marijuana grow operation, potted plants, chemicals, and grow lights filled the room. I backed out of the room, and made contact with the female in the kitchen who identified herself as Heather Bellomy.

Heather began talking about what happened. She stated that Alex hit the banister rail with a hammer. I asked her if there were any weapons inside the house. Her response was "NO SIR, NOT

THAT I'M AWARE OF". She stated that Alex cut the lock off the garage to get to a snowblower. She stated that there were no threats made, and that they don't even talk. She stated that Mark lives downstairs, and stated that the landlord was Mr. Myers. She mentioned to just getting over covid. She stated that she had nothing to do with the cultivation.

Detective Turner arrived inside the residence and I briefed him on what I had at this point. I asked Bellomy if she would consent to search of the residence for weapons. Her response was "RATHER NOT". I advised her of Miranda Warnings in reference to the offense of cultivation. Bellomy advised she understood her rights. While speaking with her further she said she wanted to share something with me. I asked her as long as she understood her rights, and that her statement was made freely and voluntarily. She stated that she understood. She stated that there was a "RIFLE" under the bed. I did not confirm that the rifle was under the bed.

Officer Nolen arrived on scene. It was determined that Bellomy had an active warrant for her arrest out of Richland County, and that the warrant was confirmed. Sgt. Baker requested she be transported to station for an interview. I allowed the female to put on some other clothing due to the weather conditions. I escorted her into the bedroom for clothing, and while doing so I noticed a single spent casing on the floor in front of the bed. It appeared to be .22 cal rifle casing. The casing was not disturbed. Bellomy was taken into custody.

Officer Nolen remained on scene, and I transported Bellomy to station and placed her in the interview room.

Supplement Title: MAN WITH A GUN

On February 3, 2022 at 1417 hours Sgt. Baker and Officer Swisher were dispatched to 91 Broadway St (Upstairs) in reference to a male with a hammer and a gun.

While en-route, Dispatch advised that the caller, Mark Stephens, who lives downstairs at 91 Broadway St stated that his upstairs neighbor, Alex Tittle broke into their shared garage with a hammer and then fired a rifle into the air and that he was now upstairs with his girlfriend, Heather Bellomy (later found to be his wife, Alexis "Heather" Bellomy Tittle). Mr. Stephens told Dispatch that " it was getting bad" and to send "as many Officers as you can" to 91 Broadway. Mr. Stephens stated that Mr. Tittle was "freaking the fuck out." Mr. Stephens stated that Mr. Tittle had a "rifle with a scope on it." Mr. Stephens stated that he was now hiding in his basement because he was "scared for his life." Mr. Stephens went on to say that he was "scared that he is gonna come in here and kill me right now." He continued, "I'm afraid to go up on the first floor."

Sgt. Baker and Officer Swisher arrived at the residence and blocked off Broadway St Northbound and Southbound. I responded from the police department and although I was wearing my body-worn camera, the audio of my involvement is broken and fragmented due to a defect in the camera. I drove to the North/South alley that runs from E. Smiley Ave until Flint St and also runs behind 91 Broadway St. I positioned myself behind a shed at the rear of 89 Broadway with my handgun drawn at the low-ready, with a clear viewpoint of the upstairs apartment entrance/exit. I could see that the screen door was closed; however the interior door just inside that was open, allowing me to see into the apartment but through a pane of glass on the exterior door. The upstairs apartment where Mr. Tittle resides only has one entrance/exit and it faces said alley to the East. The apartment is accessible via a wrought-iron-type set of stairs. The Ohio State Highway Patrol and the Richland County Sheriff's Office was contacted for assistance. Trooper Gillum from OSHP arrived and also placed himself in the rear of 89 Broadway with a long-rifle. Sgt. Baker covered the front of the residence with a patrol-rifle. Officer Swisher was stationed at the South East Corner of 89 Broadway, also with a patrol rifle.

Chief Combs contacted Hostage Negotiations Team (HNT) (based out of Ontario PD) and the Allied Special Operation Response Team (A.S.O.R.T.)(S.W.A.T) to assist. Both units were preparing to come to Shelby. Chief Combs then began to call Mr. Tittle when he called into the police department . Mr. Tittle stated that he was "having an issue with his neighbor lately" and that he saw that "the cops have the road blocked and stuff." Chief Combs advised Mr. Tittle of the complaint that he fired a round from a rifle. Mr. Tittle responded "A gun, no I had a sledge hammer." Chief Combs also told Mr. Tittle that there was an allegation that he broke a window out on a garage. Mr. Tittle started to get agitated and stated, "No, no, no, now that garage door that's broke, ok, that is in my lease, that's my garage. My landlord has his car sitting in it. My snowblower was on the inside of that garage and I need belt so I can plow my car out and stuff...well I asked the landlord, "hey could I get in that garage to get my snowblower so I can see what size belt I need." And he told me that Mark was gonna bring it out and leave it in the snow. And I was like don't do that, just unlock the garage, let me know when it's unlocked and I'll go get it out and that was it....I had a 15 pound sledgehammer." Chief Combs asked Mr. Tittle if his girlfriend was in the apartment with him or if someone else was

in the apartment with him. He stated, "no, she's not home." Chief Combs told Mr. Tittle that he needed to come outside and speak with Officers, but to make sure he didn't have a gun on him. Mr. Tittle stated, "I don't, there's none here." He continued, "I don't have no guns, I just wanted to make sure you guys are comfortable too." Chief Combs then called off HNT and ASORT once he knew Mr. Tittle came outside.

I could see that Mr. Tittle began exiting his residence and started coming down the rear stairs. He had his hands in the air. At the bottom of the stairs, I placed Mr. Tittle in handcuffs while Officer Swisher and Trooper Gillum covered me with their rifles. Mr. Tittle was compliant with my requests to place his hands behind his back; however, once he was placed into cuffs, Mr. Tittle began yelling and screaming (to another neighbor) the circumstances stating that this was all over a snowblower. I asked Mr. Tittle if he had any weapons on him and he told me that he didn't. He did tell me that he had a handgun but that it was not inside the apartment. I asked Mr. Tittle if he fired a gun and he stated that he hadn't. Mr. Tittle went on to tell me that the incident started with Mr. Stephens over the snow blower. Mr. Tittle also told me that no one else was inside the residence.

Officer Swisher and Trooper Gillum then conducted an exigency search of the residence due to the discrepancy of Mr. Stephens stating that there was a female inside and Mr. Tittle's assertions that no one was inside. At this point, Officers conducted the exigency search 1.) to make sure no one else was inside the residence with weapons, 2. Officers were concerned for Ms. Bellomy's safety due to a history of domestic violence between she and Mr. Tittle and that there was a possibility that she was harmed, or being held inside against her will. Mr. Tittle got upset and started yelling that we didn't have permission to enter his residence. I advised him for the reasoning of our search; however, he didn't seem to hear or comprehend me because he was being disorderly by screaming and yelling. Sgt. Baker then transported Mr. Tittle to the police department (He read his his Miranda Warning while he was in transport to the police department).

I then walked with Mr. Tittle out to Sgt. Baker's cruiser and placed him inside. I returned to the residence as I heard Officer Swisher on the radio state that he and Trooper Gillum had located a marijuana grow operation as well an an unharmed Heather Bellomy-Tittle inside. Officer Swisher read Ms. Bellomy her Miranda Warning and asked if we could have consent to search the rest of the residence. Ms. Bellomy denied the consent to search. I advised Ms. Bellomy that we would be obtaining a search warrant for her residence. A check of NCIC/LEADS showed that Ms. Bellomy had an active warrant out of the Richland County Sheriffs Office for FTA on arraingment for Driving Under Suspension. Officer Swisher showed me to a small room off the Northside of the kitchen where I observed approximately 10 marijuana plants as well as heaters, thermometers, growlights and assorted paraphernalia used to cultivate marijuana in plainview. I photographed the exterior of the residence and then returned to the police department.

Officer Swisher remained at the residence with Ms. Bellomy until Officer Nolen arrived to relive him. Officer Swisher then transported Ms. Bellomy back to the Shelby Police Department where she was placed in an interview room. Officer Nolen then remained at the residence until Sgt. Bushey and I

returned with the search warrant (22-01734) at 1856 hours. Once back at the police department, Officer Swisher advised me that when Ms. Bellomy went into a bedroom (to put on warmer clothing) (while still at 91Broadway St) as she was clad in a t-shirt, he observed a spent rifle round on the floor of the bedroom.

I went into the interview room and spoke with Ms. Bellomy. I asked her to explain to me how this situation unfolded. She stated, "a snowblower...we just wanted to get our snowblower out to blow the driveway and it's something that's been a point of contention since the weather has been getting bad. Alex said he was going to cut the lock off if we couldn't get to it. I wasn't communicating with Mark directly, I was communicating through the landlord. The landlord text back and stated that Mark was going to put it outside and that upset Alex because he was like "why can't I just go get my snowblower and put it back"....because it's in our lease that we are supposed to have access too. So I had walked down to the Duke because I couldn't get out of my driveway. He said that he banged on the railing with a sledgehammer, but that's really all I knew about. I didn't know that there had been a gun in play. The gun was supposed to be at his mother's house. So I didn't even know it was there until I was told that it was there."

I asked Heather if she was telling me that she wasn't there when this occurred. She stated, "Not when there was any...I had gotten there right when he told me "I bet he calls the cops" and then you guys showed up not to long after that" I asked what else Alex said. She stated, "Nothing really, like he didn't have any direct contact with Mark...I don't even understand how this snowballed into this." I asked Heather if she was there when Alex went out and banged on the lock. She stated, "no but I seen him with the hammer....that was sitting on the microwave thing." I asked her if she ever saw Alex leave the house with a gun. She stated, "no....the only thing I seen Alex do was when he came in he stomped in the kitchen, then he stomped in the foyer then he stomped in the living room, like jumped...I don't know...cause he told me he hit something really hard and it wasn't Mark...I don't know what that was, I didn't hear anything. It happened right when I was coming up the street and I didn't hear anything...I don't know how the gun got brought into this anyway.

I asked Heather when she got home. She stated, "I got there about 10-15 minutes before you guys got there...it wasn't long at all....I caught the literal tail-end of it. I asked her if Alex was inside the residence when she arrived home. She stated that no, "we came up the stairs together." I asked her if he had a hammer in his hand. "Yah," she said. I asked him if he had a rifle in the other hand. "No," she stated. I asked Heather when the last time was that Alex touched the rifle. She stated that it would have been a week or two prior when the two of them shot the gun in Morrow County. I asked her if there were any other guns inside the residence. "No sir," she stated, "not that I'm aware of...the re better not be."

I asked Heather if Alex used any drugs other than weed. She stated that he didn't. "I take Suboxone because I'm a recovering drug addict," she said. I asked her if Alex used Meth as his behavior was indicative of someone who uses that drug. "Im not gonna lie to you it was a problem over the summertime, but I pretty much told him it was that or me." Heather went on to tell me again that what

upset Alex was that he couldn't get to the snowblower in the first place..."but I don't think he did anything about it," she said. I asked her if Alex got mad because Mark touched his Snowblower. "Yah," she said. Heather denied that she ever heard Alex threaten Mark. 'They haven't even spoken in I don't know how long," she said. I asked why Alex and Mark didn't get along. She stated, "becaus e over the summer, Mark had probably told me some things that he probably shouldn't have, it was about when me and Alex broke up, when all the meth stuff was going on, after I left, you guys were involved in that too. Mark had told me about a woman being up there, so that caused a huge issue. So from then on, him and Alex were not getting along...They were not talking...any communication is done through Mr. Myers (landlord). The last time I talked to Mark was when I asked him to flip my breaker."

She stated that she was not being held hostage and that some credence could be given to that statement due to her previous tumultuous history with Alex, but "none of that is going on now." Heather stated that she was not physically abused today and denied that Alex had ever struck her. She again denied that there was any crack/meth use in her residence. I again told her that I wasn't sure she was being honest with me about what she witnessed. She stated that she never saw Alex with a gun. I advised her about the spent round in her bedroom. She stated, "well there probably is a few, cause when we go out to Jim and Terrys we take a magnet, cause he doesn't like shells being around because there is a beanfield. We pick all those up and they get stuck in pockets, so you will probably find a few."

I asked Heather if the marijuana grow was hers. "That's all his...that's his hobby." I asked her how many plants she had. "I don't know...my clothes are in the closet, that's all I do and my dryer is in there....there is probably no more than ten. There are a few behind the black light trash bag because they have to be separated when they are flowering. They are at different stages of growing...but that little area...I mean that little spot is the only spot you will find anything in relation to drugs. And there is a rolling plate in the living room drawer for weed to roll joints on...other than that, there is nothing in there."

Heather then told me that the rifle belonged to Alex's mother Tammy Thoman. I then concluded my interview with her.

Sgt. Baker advised me that he interviewed Mr. Tittle in the interview room just prior to me interviewing Heather. On the recording (which starts before Sgt. Baker begins questioning), Mr. Tittle is seen making calls to his attorney and to his mother, Alex said that he and Heather walked down to the Duke Station together, (not alone as she told me above). Mr. Tittle stated that they decided on the way back to contact their landlord in reference to their snowblower. Alex admitted to coming home and seeing his snowblower outside and the locked garage door. He stated that he then went to grab the sledgehammer to break the lock off the door. Alex also told his mother that he slammed the sledgehammer down on his railing to show Mark that he "wasn't messing around." Alex also told his mother that Heather was in the house when we arrived. Alex told his mother that he didn't have any bullets for the rifle and denied shooting it. He stated that he last shot the gun a couple

days prior. Alex stated that Mark knew that he had a rifle (something Mark would deny). Alex also told his mother that Heather "witnessed the whole thing" and that we found "the other shit." He also acknowledged that he knew Heather had warrants.

Sgt. Baker then came in and asked Alex what firearm we were going to find. Alex stated that we wound find his mothers rifle and acknowledged shooting it in the past, but denied shooting it today.

Dispatcher Neumann advised me that while Officers were at the scene, Mr. Tittle's mother, Tammy Thoman called into the police department and stated that her son just called her and stated that he was "being put in the backseat of a police cruiser with his wife over a gun issue." She stated that she left her rifle at her son's residence "for him to clean" and wanted to make sure that it "wasn't my gun involved in this situation."

Based on the above listed factors, Sgt. Bushey drafted a search warrant for 91 Broadway St (Upstai rs). It was approved by Law Director Eyster and subsequently signed by the honorable Judge Studer . Sgt. Bushey and I then traveled to 91 Broadway to execute the search warrant of the Tittle's residence. Officer Artrip also assisted with searching the residence. I photographed the scene and then searched the residence. The following items were located and seized during the search warrant.

- 1. (2) metal grinders, Pink pipe, Zig-Zag rolling papers Found in a Coffee table in living room -Found by Sgt. Bushey
- 2. (2) plates, snort straws, rolling papers, and an unknown orange substance Found in a Coffee table in living room - Found by Sgt. Bushey
- 3. (3) 9mm round of ammunition Found in a Coffee table in the living room Found by Sgt. Bushey
- 4. (1) spent .17 rifle round Found on the bedroom floor Found by Officer Artrip

- 6. (3) digital scales Found in a bedroom vanity on the West wall Found by Officer Artrip
- 7. (1) metal grinder with crank Found on dresser on the East wall of the bedroom Found by Officer Artrip
- 8. (1) metal hammer Found in the kitchen Found by Detective Turner
- 9. (7) marijuana plants Found in North room (outside enclosure) Found by Officer Swisher/Officer Artrip
- 10. (3) marijuana plants Found in North room (inside enclosure) Found by Officer Artrip

No other rifle rounds (besides the spent casing) was located in the residence. The rifle was located underneath a bedroom in the only bedroom with an empty magazine inserted in it. The rifle was not in a riffle case.

After we concluded with the search warrant, I again went back to speak with Mr. Stephens (this time with a working body camera). I asked Mr. Stephens to explain to me what happened again. He stated that his received a call from his landlord Robin. He stated that Alex communicates with him through Robin because Alex had caused problems with him before. Mr. Stephens stated that Robin told him that Alex wanted him snowblower out of the garage. Mr. Stephens stated that he wasn't home at the time, but stated that he would be back shortly. Mr. Stephens stated when he arrived back at the residence, that he brought the snowblower out with his gas can and then re-locked the garage up.

Mr. Stephens stated that it was quiet and he went in his office and sat down. He continued that about 3 minutes later he heard Alex screaming "Mark left my fucking snowblower outside." Mr. Stephens continued, "And he building himself up, like he's going crazy because I left his snowblower in front of his car...l drug it out there because I was trying to be nice and considerate, but he didn't look at it like that and he is getting pissed and getting himself worked up, and then he screamed "Heather, grab my gun and my bullets." Mr. Stephens stated that he then went to his window (which is directly beneath the staircase that ascends to Mr. Tittle's apartment) and he observed Mr. Tittle descend the staircase with a mallet in his left hand and a "long rifle in his right hand...it had a scope on it. He then went to the garage and started smacking the lock, smacking the door, beating the crap out of it. When he comes back he grabs his gas can with the gun and possibly the hammer still, unless he threw it out there...I couldn't believe it, I was in shock, in disbelief that this was going on. Now he has made threats before about shooting people and I got text messages on my old phone that he was going to kill himself and kill everybody....So he went upstairs...so he was up here, where we couldn't see each other no more (pointed to the upstairs landing directly outside Mr. Tittle's front door)...! yelled "are you serious?" and then he shot his gun...he then goes over here and I thought he was kicking in the door for a minute, it scared the shit out of me, but he was actually upstairs stomping. He must have stomped between 80-100 times. It lasted for a minute and a half straight. He was just jumping up and down and throwing a temper tantrum like a kid after he shot his gun up there... I was convinced that he was going to come in here and shoot me."

Mr. Stephens continued, "I didn't know what he was going to do. He was not in his mind...he has threatened to beat up the landlord. I just did what I was told. I was told to go get the snow blower and bring it out...I did that and it just pissed him off." I asked Mr. Stephens how certain he was that Mr. Tittle fired a gun. He stated that he was "90-95 percent sure...! didn't see it, but when I was standing right here and I said, "are you serious?" It sounded just like a .22 pop or something." I asked Mr. Stephens if he would know the difference between the sound of a mallet hitting the iron stairs vs. the firing of a gun. He stated, "I've shot guns before...it sounded just like a gunshot because it had that little crackle to it. It didn't sound like an impact, it sounded like an explosion...you can tell when there is a noise from something under pressure from like an engine or bullets or something, there is a specific noise when it is under pressure and it sounded like a little .22 pop. I can't say I'm 100 percent certain because I didn't see it, but if you tested him for Gunshot residue it would be there." Mr. Stephens stated, "He's been acting crazy for a long time. I've complained about this before...I

don't feel safe sleeping here, I'm afraid he's going to come in the night...he's a nut case...l don't trust his intentions, he doesn't think properly. He's unreasonable and can't talk anything out, he's just ready to fight to get his way." I asked Mr. Stephens if he felt that Mr. Tittle was going to harm him. He stated, "I knew that he was going to, I just knew it."

I asked Mark to come to the police department tomorrow to give a written statement. He stated that he would. He stated that he wanted notified if Mr. Tittle was released stating, "he hates my guts, he's probably going to want to get me after all this crap. I haven't spoke to them in months." I asked Mr. Stephens if he could hear Heather upstairs as well as she told me that she wasn't home when all this occurred. "I heard them both...I can hear it plain as day." He stated that he can hear everything from the upstairs apartment because of a void between the apartments. He stated, "they were both working each other up. They were getting mad because I have access to the garage and they don't." Mr. Tittle stated that we (the police) have been to the Tittle's residence numerous times since they moved in."

Officers Nolen and Artrip transported the seized property back to the Shelby Police Department where it was placed into evidence. While processing the rifle into evidence, Sgt. Scott, a firearms armorer for the Shelby Police Department stated that Mr. Tittle's rifle was a bolt-action rifle, meaning that it would not automatically eject a casing upon its firing. The shooter has to manually eject the round via a bolt-action on the side of the rifle. Thus, Mr. Tittle would be able to control where he ejected said round. Sgt. Scott also showed me that the round found in the bedroom was a rim-fire cartridge, meaning that the firing pin strikes the cartridge on the outside as opposed to a center-fire pin which strikes the cartridge in the center. Sgt Scott matched up the firing pin from the rifle to the end of the spent cartridge and there were corresponding markings. The spent round was fired from the located rifle.

I charged Mr. Tittle with the following.

Mr. Title was served with his summons' by Officer Artrip and Sgt. Scott. He will await his initial appearance in Shelby Municipal Court on February 7, 2022 at 0900 hours. He was also advised of his bond of \$1,575.00.

On 02/03/2022 at 1413 hours Ofc. Swisher and I were dispatched to 91 Broadway in reference to a man (Alex Tittle) that had discharged a rifle into the air and was hitting objects with a Hammer. Dispatch advised that the caller was a resident of the downstairs apartment. While enroute and after arrival dispatch remained in contact with the original caller. Dispatch advised that the caller believed there to be a female (Heather Bellomy-Tittle) also inside the upstairs apartment with Title.

Upon arrival Ofc. Swisher and I blocked Broadway with out cruisers. My cruiser was positioned North of the residence while Ofc. Swisher was just south. Chief Combs was updated by dispatch-as a result surrounding agencies were requested to respond for assistance. Detective Turner and a Ohio State Highway Patrol Unit arrive shortly after arrival.

While holding the above mentioned positions, Chief Combs was able to make contact with Title by phone. Chief Combs indicated that Tittle would be exiting the residence in compliance and wanted to speak to officers on scene. Shortly therein after, Ofc. Swisher confirmed that Title had been secured. Det. Turner then escorted Title to my cruiser. Just as Tittle was being transferred into my custody, Ofc. Swisher radioed that he had located a "Marijuana Grow Operation" inside the residence. Ofc. Swisher and Det. Turner remained at the residence while I transported Title to the Police Department.

While traveling to the Police Department Tittle was advised of his Miranda Warning's. Tittle did acknowledge that he understood his rights and did not have any questions concerning them.

On station I placed Tittle in the interview room. Tittle was advised that the interview as well as the entire Police Department was recorded. Tittle was placed in the interview while he was still in position of his personal cell phone. I allowed Tittle several minute in the room alone. During this time Tittle made phones calls to his mother and attorney. These calls are described in Ofc. Turner's supplement.

After a few moments I entered the interview room where I spoke with him briefly about the situation. Tittle was confronted about the Marijuana and advised that a Search Warrant will be conducted on his residence. I inquired to the location of any firearms in the residence. At first Tittle insinuated that there was no rifle, but a 9 mm handgun but later clarified that his mother's rifle was inside the residence. Tittle denied discharging the rifle however.

Tittle was asked to explain the situation. Tittle advised that he and his down stairs neighbor (Mark Stephens) do not get along. Tittle advised that they have mutual access to the properties garage-insi de the garage Tittle stores his snowblower. Tittle advised that a lock had been placed on the garage which did not allow him to get his Snowblower. As a result Tittle used a hammer to brake the lock. Tittle expanded that he then used the hammer to "bang" on thee rail of his apartment (upstairs) to harass/annoy Stephens. Tittle elaborated that Stephens and Tittle also have a situation involving a cat that has caused ongoing problems. Tittle later admitted that he stomped around his apartment on purpose to "bother" Stephens. Again Tittle denied discharging or touching the firearm today.

On 02/04/2022 Mr. Tittle was able to post his bond of \$1575.00. Shortly after his release, Mr. Stephens arrived at the Police Department to provide a statement. I collected the statement and scanned it into e-storage.

Mr. Stephens confided that he was upset and scared that Mr. Tittle had been released. Mr. Stephens advised that he felt that Mr. Tittle would retaliate against him in some way. I provided phone numbers for Domestic Relations court and explained the protection order process to him. I also contacted the city Law Director on his behalf. Law Director Eyster advised to contact Judge Studer to discuss bond revocation and other options. I was forced to leave a voicemail for Judge Studer at this time.

I advised Mr. Stephens to at least consider staying somewhere else for the short term Mr. Stephens advised that he would definitely do this and indicated he would not be going back to the residence.

About a hour after leaving the Police Department, Mr. Stephens contacted "9-11" to report that Mr. Tittle was flooding his apartment with water and was being threatened through the walls.

Ofc. Swisher and I were dispatched to his residence to speak with Mr. Stephens. Mr. Stephens allowed me to listen to a recording-which he fast forwarded through most. The recording was about 12 minutes in length. Mr. Stephens wanted officers to here the gushing of water coming from the basement stairwell ceiling. I was able to hear this on the recording and there was some dampness on the floor of the basement. Also a plastic container was filled with some water as well.

When asked, Mr. Stephens did admit that Mr. Tittle was listening to Rap music that contained violent phrases. Mr. Stephens advised that Mr. Tittle would yell these lyrics loudly near a thin piece of floor. Mr. Stephens stated that he felt these lyrics were threatening to him.

Officers went upstairs and spoke to Mr. Tittle. Mr. Tittle stated that he was doing laundry and cleaning his apartment. Mr. Tittle admitted that he was listening to rap music-"Jamming out". There was evidence that Mr. Tittle had just cleaned things up and the washer was running. While looking at the washer, I observed a small amount of water that pooled on the floor next to the drain of the washer. The washer was sitting directly above where Mr. Stephens reported the leak. It was plausible that there was a leak from the washer, however there was a gap where pipe went the floor. This could also be the source of the water running down the stair case.

Officers counseled Mr. Tittle about having his bond revoked if he is proven to be harassing Mr. Stephens. Mr. Tittle advised that he understood and he had gotten the same advice from his attorney.

Officers returned downstairs and advised Mr. Stephens of the above. Mr. Stephens appeared unhappy however he understood. Just as I was finishing up Judge Studer contacted me by phone. Judge Studer advised that nothing being reported would constitute a bond revocation or an arrest.
