NARRATIVE

Officers were dispatched to the incident location in reference to a possible hit skip. Upon officers arrival, OF#1 and IO#1 were standing outside their vehicle (FSB6031). OF#1 and IO#1 advised that the vehicle which was pulling out as officers arrived (FPK4940), was leaving with the individuals who wrecked into their vehicle.

A car stop was initiated on FPK4940. Contact was made with OF#4, OF#5, and IO #2. OF#4, OF#5, and IO#2 were detained and transported back to the incident location.

Contact was again made with IO#1 and OF#1. OF#1 and IO#1 stated VI#3 and OF#2 were all in the listed vehicle with them. OF#1 and IO#1 advised OF#2 attempted to do a drug deal with OF#4 and OF#5 but they ran off with OF#2's drugs. OF#1 and IO#1 stated they gave chase after OF#4 and OF#5 were picked up by OF#3. OF#1 and IO#1 advised OF#3 struck a few cars while fleeing and rammed their vehicle. OF#1 and IO#1 stated OF#2 switched driving with OF#1 at some point during the chase. OF#1 and IO#1 advised OF#3 finally stopped the vehicle at the listed location when OF#4 and OF#5 got out of the vehicle and OF#2 attempted to run into them. OF#1 and IO#1 stated OF#2 hit OF#3's vehicle and then struck VI#3 and VI#4's vehicle. OF#1 and IO#1 advised OF#2 exited the vehicle and then chased after OF#4 and OF#5 who fled the scene.

Contact was made with OF#4, OF#5, and IO#2. OF#4, OF#5, and IO#2 all stated IO#2 was not involved in the incident. IO#2 was released. OF#4 and OF#5 advised they got into OF#3's vehicle when OF#2 came chasing after them threatening to kill them. OF#4 and OF#5 advised OF#1, IO#1, OF#2, and IO#2 were all in the vehicle which was chasing them. OF#4 and OF#5 stated OF#3 tried to lose OF#2. OF#4 and OF#5 advised OF#2 rammed OF#3's vehicle trying to get them to stop and OF#2 also struck other vehicles while trying to get them to stop. OF#4 and OF#5 stated they had OF#3 drive them to the listed location and they then attempted to flee the scene on foot. OF#5 advised when he exited the vehicle, OF#2 ran into him with the car and then struck OF#3, VI#4, and VI#5's vehicles. OF#4 and OF#5 stated they fled the scene on foot and later returned to get into OF#4's vehicle to try to drive home.

Contact was made with WI#1. WI#1 stated he came outside after he heard OF#2 wreck into VI#4 and VI#5's vehicles. WI#1 advised he saw one of individuals involved throw an unknown bag under one of the vehicles that were struck. WI#1 stated all of the males involved then fled the scene, leaving OF#1 and IO#1.

MFD responded to the scene. All parties advised they did not need medical treatment. A small bag of marijuana was found under the rear right wheel of EKX7143. The listed marijuana was submitted to the lab. Photographs were taken. See film pack 11221, frames 150-174 and film pack 11225, frames 107-111. OF#1 gave a taped statement. IO#1, OF#3, OF#4, and OF#5 completed written statements. All statements were submitted to records. Children services responded and took custody of VI#3. OF#1, OF#3, OF#4, and OF#5 were all arrested, transported to RCSO Jail, and given the listed summonses. This officer will follow up on charges for OF#2 at a later date.
