

Mark also advised me that this is not the first time that Brian has assaulted Jessica. Mark stated that sometime in 2015 approximately March of 2015 while Jessica and Brian were in Pittsburg, Pennsylvania for a concert Brian did assault Jessica in a hotel room. Mark stated that he was not sure what came of the incident but did know for certain that Brian spent a night in jail in Pittsburg and Mark's ex-wife and sister did go to Pittsburg and pick up Jessica that night. According to Mark he was unsure if charges came out of the ordeal or not.

This interview took place on January 26, 2016 at the address of 2812 Center Dr. in Zanesville, Ohio.

I questioned Deborah Hennessey about her knowledge and involvement in a case that took place on January 26, 2016 involving her son, Brian Hennessey. She explained to me that on the 25th around 11:30 a.m. they had realized that Brian had not shown up for work at the family business and she decided she was going to go to his address to check on him. She said that she has a key to the location and was concerned about his wellbeing because she knows that he and his wife have been having some problems.

She said that when she arrived at the address just before noon she entered into the home through the garage and into the kitchen. Once she opened the door she heard a lot of arguing towards the back of the house. She stated that she saw Brian and Jessica walking down a hallway from the area in which the master bedroom was. She explained that she could not tell exactly which room they had come out of. That are a couple of bedroom down that hallway. She said that they were being very loud and belligerent with each other. I asked her whether or not they appeared to have been in a physical altercation. She explained that Brian had a red mark on his face and that Jessica appeared disheveled and was adjusting her shirt. She said that they continued to scream and yell at each other. She said that she had a difficult time understanding what the conversation was about however she was able to make out that Jessica was upset because Brian may have cheated on her with a prostitute and Brian was upset with Jessica for disrespecting her and Brian's father identified as Patrick Hennessey because they are financially supporting her hair salon.

She said that they were yelling at each so much and that it was frantic that she could not get a word in edgewise. She said that she was trying to get them to calm down and talk about what was going on. She said she eventually got them to sit at the kitchen table. She said one was sitting at one end. The other was sitting at another and she sat in the middle. She said that Jessica was screaming and yelling that she believed Brian had broken her nose and Brian was yelling at Jessica stating that she needed to sit down and talk to his mother about the financial situation involving the hair salon.

She said that she was there for a good hour to an hour and half trying to get them to calm down and get some order in the conversation however she was unsuccessful. She said that it was extreme chaos and she got to the point where she was trying to talk Brian in to leaving the residence with her. She

said that she got into a small argument with Brian and that he was refusing to leave stating that he was going to stay there and get things straightened out. Deborah said that because she could not get involved in the conversation and could not accomplish her goal in communicating with Jessica about the financial issues she had left the home.

She said later on that afternoon somewhere around 3:30/quarter til 4 Brian showed up at her residence stating that he had left his home and walked over there wanting a place to stay. She said that Brian also requested she go and pick up his children. Deborah said that after she left and picked the kids up she had returned back to the home and they did not talk about what was going on because she had 4 of her grandchildren and did not feel that it was appropriate to talk about things in front of them. She said Brian was complaining of a headache and laid on the couch.

She said a short time later her husband, Patrick, showed up and they were sitting around the home when Jessica called wanting to talk to Brian. She said that after Brian spoke to Jessica on the phone he wanted to go back to the residence. Deborah said that she told Brian that it was not a good idea that he should just stay there however Brian decided that he was going to go back to the home. Deborah said that her husband, Patrick, then stated that he was going with him and that the two should not be alone. She said that's when Brian and Patrick left the residence.

I guestioned Deborah as to whether or not Jessica had ever mentioned anything about an assault or ever ask for assistance in leaving the home during their conversations. Deborah said that she did not mention anything other than the possibility of a broken nose and Deborah said that she had just noticed the scratches and their attitudes. She said that the conversation never went towards any type of physical assault. She said that mainly Brian and Jessica just continued to scream and yell at each other as normal. When she made the statement that they scream and yell at each other is normal I asked her to clarify and she said that since the two have been together it's been light oil and water and that they are constantly arguing back and forth and have had several incidents in the past which involved law enforcement. She stated that they did in fact have an altercation at a hotel in Pittsburg. She said that she was not going to elaborate on the incident because it was unnecessary and was embarrassing for Jessica however Brian did get arrested. She said there was also an occasion involving the Zanesville City Police Dept. where Brian had to make a phone call to have Jessica removed from their home located at 2812 Center Dr. Deborah said Brian was at their house at the time and Jessica was furious. She said there was also a time that Brian had to sit in his own driveway and lock the doors to his car and contact the Sheriff's Office because Jessica was being so aggressive with him. She is unsure if any arrests were made by the Zanesville City Police Dept. or if any charges were filed through the Muskingum County Sheriff's Office.

She explained that their relationship has always been poor and that the only thing that kept them together was the business and the children. Deborah explained that her and her husband have invested quite a bit of money in Jessica's hair salon and the financial issues there are part of the problem. She said that both Brian and Jessica have also had substance abuse problems and that Jessica is a recovered addict from using pain pills.

Deborah went on to state that even though she did not have a lot more detail about what had taken place at the house she was confident in saying that the two should not be together.

When speaking with Patrick Hennessey he explained to me that he arrived home from work to find Brian and 4 of his grandchildren were at the house. He said that they did not really speak of the incident until Jessica called wanting Brian to come back to the home. Patrick said that when Brian decided that he was going to go back to the residence he felt it necessary to go with him in order to keep the situation somewhat civil. Patrick said that he did not believe that Brian and Jessica should be alone so he went with him. I questioned Mr. Hennessey as to whether had ever received any phone calls through the day from Brian. He explained that he did not that Brian was already home when he arrived there and that the only time they communicated about the incident was on the ride to Brian's home. I asked him what that conversation consisted of and he said that Brian did not really talk much about what had taken place. Patrick said that he was basically explaining to Brian that their relationship was poor and that they should not be alone together and was giving him some advice on what he needed to do.

I asked Patrick as to whether or not he was engaged in any conversation with Jessica once they arrived at the address. He said that when they first got there Jessica was extremely upset with him and screaming and yelling at him telling him to get out of the home. He said that he was able to get her to calm down a little bit and explained to her that he wanted to be there to keep them from being in an argument. He said that he did not care if she called her father or another relative but someone needed to stay at the home to keep things civil. He said that when the calmed down and shortly after a deputy arrived at the address to arrest Brian.

I again asked him if he ever discussed any details of physical altercation or anything that had taken place at the home and he did not.
