Re: 110 North Central Ohio clergy safeguard society from the harms of recreational marijuana and the softening of drug enforcement laws

Dear Local Economic Leaders:

The stabilizing Judeo-Christian foundations of our society are under assault. With a skyrocketing Opioid Crisis and the implementation of drug-legalization policies, our vibrant communities are being threatened. As the Bible says in the Book of Psalms, "If the foundations be destroyed, what can the righteous do?"

With Congress actively pursuing the passage of HR 3617 to federally legalize marijuana, and with Congress debating the allocation of \$30 million in federal taxpayer funds to subsidize drug paraphernalia (i.e. crackpipes) and syringe exchanges, (1) it is apparent there are coordinated efforts to decriminalize illicit drug use and further corrupt society.

Closer to home, the Ohio Legislature is considering the Ohio HB 382 recreational marijuana proposal, and the Ohio HB 498 expansion of non-medicinal marijuana use. If these two measures are successfully defeated, it is our understanding a state measure to legalize marijuana will automatically be put on the ballot this coming fall.

We support vibrant communities and encourage policymakers to "Believe Local." Therefore, based on local community standards reflected in its history and leadership, and as clergymen representing one hundred and ten (110) congregations across North Central Ohio, we believe the legalization of recreational marijuana and the relaxation of drug enforcement laws like syringe exchange programs and designated outdoor refreshment areas disrupt health and safety and are morally wrong.

Results from states who have already legalized the Schedule 1 narcotic: marijuana, have shown negative impacts on brain development in youth, increases in road deaths, surges in chronic absenteeism, and the fortification of the black market. (2)

Further, it is our understanding the Village of Crestline in October of 2021, had a month-long experimental "designated outdoor refreshment area," or DORA; the first community in Crawford or Richland counties to do so. (3)

In 2017 the Ohio General Assembly allowed municipalities to have the option to allow people to publicly consume alcohol and be exempt from Open Container Laws inside a DORA zone. It is believed local leaders are considering replicating these ordinances in other nearby localities that will endanger traffic safety with pedestrians (4) and burden our already depleted police departments.

As key stakeholders with numerous drug treatment ministries, we believe the legalization of marijuana, and the ratification of syringe exchange programs and DORA zones do not meet local community standards. There is no question the faith community has historically been unified with one voice in opposing the legalization of marijuana. (5-7) thwarting syringe exchange programs, (8) and countering beer gardens on public property. (9-10) After all, several area police departments display the words "In GOD we trust" on their patrol vehicles.

Our local community standards are based on Judeo-Christian values. You may recall, national headlines of lead clergymen from 150 local congregations across North Central Ohio declaring 2019 as the "Year of the Bible." (11) Following this declaration at BibleWalk Museum, various elected leaders representing the region have publicly validated these values.

We partner with Mayor Theaker as he works to "make Mansfield the best city in which to live, work, worship and raise a family." (12) We agree with the Ontario City Council President Gallo who said "Ontario is a faith-based community." (13) We support Mayor Miller as he "gives the City of Ashland to the LORD Jesus Christ." (14) And we join the Board of Commissioners in proclaiming "Richland County as 'God's Land." (15) These are just several public statements reiterating this theme.

In conclusion, just as the "Buy Local" campaign has been ongoing to promote local businesses, local houses of worship are encouraging our economic and civic leaders to "Believe Local" to preserve a vibrant future for our region by adhering to our local community standards. This can be done by safeguarding our communities from the harmful effects of marijuana and the softening of drug enforcement laws like syringe exchange programs and DORA zones. In the words of our state motto, "With GOD all things are possible."

The following clergymen representing one hundred and ten (110) congregations throughout North Central Ohio are urging the Mayors and Chamber of Commerce's to "Believe Local" and oppose legalization of recreational marijuana and sanctioning of syringe exchange programs and DORA zones.
